

## Mobile Baby Sonogram Imaging Service

### Patient Disclaimer and Authorization Agreement

Mobile Baby is a communication service owned by Trice Imaging, Inc and licensed to Greater Washington Maternal-Fetal Medicine and Genetics P.A. (GWMFM). This Disclaimer and Authorization Agreement (Agreement) sets forth the terms and conditions under which you, the undersigned patient, authorize GWMFM to transmit your ultrasound examination through Mobile Baby to a mobile phone number and email address of your choice. This Agreement will be effective on the date of your signature and will be terminated one year after your last examination at GWMFM.

Once you complete and sign this Agreement, your mobile telephone number and email address will be entered into our ultrasound system and verified with you. When your ultrasound examination is complete, the sonographer will cause the ultrasound machine to send an encrypted copy of your examination to the Mobile Baby. Mobile Baby will reformat and encrypt the file and provide access to the examination through your mobile phone number and email. GWMFM will determine whether your ultrasound screening is complete and whether to transmit your images to Mobile Baby. GWMFM has the right to refuse to transmit or to delay the transmission of your images for any reason at GWMFM's sole discretion.

Both the text and email message will contain secure links and instructions on how to access the images. Images and videos can be accessed and downloaded to your mobile phone and computer.

You agree to pay all costs for the services. Transmission of the images through Mobile Baby is not a medical service and your insurance will not pay or reimburse you for the costs of the services.

The transmitted images are not considered diagnostic medical images and are not a part of your medical record; they are not to be used for your health care, diagnosis or treatment. If you want to view your medical records, please contact GWMFM, who is responsible for maintaining your medical records.

Neither GWMFM nor Mobile Baby is responsible for the security of the transmitted images once the text and email recipients you have designated download the images. By directing GWMFM to transmit your images to an email address and telephone number that you specify, you authorize GWMFM and Trice Imaging, Inc to provide the images to the person who owns or uses the email address and telephone number and any persons who may have access to the telephone number and email address.

Once the images have been accessed and each link to them is broken, the services are complete. **PLEASE SAVE THE IMAGES ON YOUR DEVICE AS SOON AS YOU RECIEVE THEM!** Mobile Baby will not store the images on its server to resend to you in case if you did not save them!

As a licensee of Mobile Baby through Trice Imaging, Inc, GWMFM is permitted to offer the services under the terms and conditions of the license. Trice Imaging, Inc does not provide, supervise, or control the care that you receive from GWMFM. Trice Imaging, Inc is not responsible and expressly disclaims all liability for the judgment or conduct of GWMFM or anyone acting under GWMFM's direction.
